Project Management Committees (PMCs) are key

set project direction

manage repositories/ build/ test/ release

vote new PMC members

vote new committers

vote software releases

Why Vote?

An official act of a PMC is an act of the Foundation

Votes are required to document PMC decisions three binding +1 and more +1 than -1

Votes are binding or not binding

PMC Members: binding

PPMC Members: not binding unless also IPMC

Community: not binding

So Hard to onboard New Committers

Discuss (real people not github ids)

Vote

Close the Vote

Invite

ICLA filing (invitee and secretary)

Account creation (infra)

Record

So Hard to fill ICLA form

Only Humans need apply

Public Name not login

Postal Address personal not corporate

Requested id and Project if applying for committer

Signature not script font detached GPG signature also accepted

Special Rules for Incubator Podlings

Infrastructure will create the account with incubator privileges

PPMC and Mentors must monitor private mail list for account creation

Mentors add new account privileges to podling resources

So Hard to onboard New PMC/PPMC Members

Discuss

Vote

Close the Vote

Invite

Record

So Hard to Release

Decide on content and release manager

Create release candidate(s)

Vote on public list: only binding votes count

Repeat until three binding +1

Publish download page, artifacts, checksums, signature(s)

Announce via Public Relations

Special rules for Incubating Podlings

PPMC has no official standing

Incubator PMC must vote on releases

Releases are voted on dev@podling first

Once vote passes with three +1 PPMC votes:

- vote goes to general@incubator for IPMC members to vote
- if all Podling Mentors cast +1, vote passes
- if not, try to get IPMC Member votes

So Hard to submit patches

Projects need "new contributor guidance"

- user documentation
- "how to contribute"
- "good first issue"

So Hard to become a committer

Join project mailing list Ask questions Answer questions

Consistency

Quality

Respectful interactions with project

High committer bar?

So Hard to Protect the Brand

Primary Issue is Name Confusion
Apache Foo® or Apache Foo™
Companies may use "Bar for Apache Foo"
Companies may use "Bar powered by Apache Foo"
Apache Foo!= "open source edition of Acme Bar"
Eternal Vigilance is Key
VP, Brand is here to help

ASF web sites must be role models

- Apache Foo™ at beginning of all pages
- Trademark notices in footer of all pages

ASF is first a community of peers
